7664-93-9	Sulphuric acid	The General Chemical – Thorold facility (Facility) is constrained in the amount of sulphuric acid it can reduce. Sulphuric acid is a critical raw material in the production of aluminum sulphate (alum), the only product produced and sold by the Facility. There is currently no substitute for the substance. Additionally, the Facility has taken significant steps to reduce the use of sulphuric acid in the past to the point that there are no other known reduction efforts that are technically or economically feasible. The Facility will not be reducing its use of sulphuric acid at this time. In the recent past, emissions reduction and spill prevention measures have been implemented, when feasible. In 2010, the Facility installed an exhaust stack scrubbing system, reducing sulphuric acid air emissions by 95%. Frequent environmental reviews are conducted to identify opportunities for such pollution prevention efforts.
